Multi-Million Weiwei Irrigation project on course, PS reassures locals

The Government, through the Kerio Valley Development Authority (KVDA) is committed to complete the 325 hectares Weiwei Irrigation Scheme Phase III Project in West Pokot County at a cost of Sh1 billion.

The project launched by President Uhuru Kenyatta in 2016, courtesy of the Italian Development Cooperation and the Government, targets to tackle food insecurity in the semi-arid region.

Weiwei Irrigation Scheme was started in 1984 after drought hit the country and has been in operation for more than 35 years. It has so far partly turned the region into a partial food basket, with residents transforming their livelihoods a great deal.

The State Department of Regional Development Authority Principal Secretary (PS), Dr. Belio Kipsang, said during a stakeholders meeting at Aturkan Hotel in Kitale Town, that Phase III of the irrigation project is now on course, adding that it faced delays due to Covid-19 and poor climatic

conditions experienced.

"The pilot project commenced so many years ago and there are overwhelming success stories. The Phase III has had few challenges but we are able to surmount them," said Kipsang, noting that the Phase has now officially started and the project will serve the entire North Rift re-

gion on food security matters, now that contractor teams from Italy are on the ground.

The PS reiterated that the project has had a great impact, citing it as one of the four key food security projects in the country. "This project has made a huge difference since its inception. There is a maize shelling facility besides doing

value addition together with mangoes, citrus fruits and avocado nurseries at Weiwei," he explained.

Kipsang exuded confidence that the start of Phase III will double the production hence increased household incomes mentioning that farmers are currently generating Sh75 million shillings annually.

Kenya to pilot model on health impact of substandard HPTs

The Kenya Pharmacy and Poisons Board in collaboration with the United States Pharmacopoeia Promoting Quality of Medicines Plus Program (USP/PQM+) is working on a post marketing costing model for estimating the health and economic burden of substandard and falsified health products and technologies in Kenya.

Kenya is pioneering the unique model which, once finalized and validated will be applied globally in other countries.

Piloting for the model commenced in February this year and is expected to be finalized in September this year and the findings will be applied to make an economic case for combating substandard and falsified (SF) Health Products and Technologies (HPTS) in the country and beyond.

The model, according to the Pharmacy and Poisons CEO Dr. Fred Siyoi is expected to demonstrate the economic and public health impact of substandard and falsified Health

Products and Technologies in Kenya once its validated and will be benchmarked by other countries in the world.

Dr. Siyoi who was speaking during a meeting between the Pharmacy and Poisons Board and the United Nations Pharmacopoeia (USP), Senior Vice President, Global Health and Manufacturing Services, Dr. Emily M. Kaine.

Dr. Siyoi commended the USP for supporting the PPB in areas of regulatory systems strengthening and expanded risk-based Post Marketing Surveillance (PMS) of essential medicines since 2010.

"Thank you for opening an office in Kenya and also for supporting the PPB in setting up our mini labs and self-directed learning system, the USTADI learning system, which has enhanced our regulatory capacity," he noted.

"There is data which is not being reported and we are finding ways on how we can integrate our PvERS system with Chanjo systems in order to aggregate the data. We continue to appeal for your support," the CEO said.
